Set-Up

- 1) Vendor set-up begins at 9:00 am. All vehicles must be removed from the vendor area by 10:30 am.
- 2) You may not be able to unload near your space, given your location. Please be prepared to transport your items.
- 3) Set-up should be completed no later than 30 minutes prior to opening.
- 4) There are no electrical spaces available.

Rules

- 1) Vendor booths must be set-up for the entire event time. You will not be allowed to drive your vehicle to your space for break-down until our event volunteer notifies you.
- 2) Displays must be manned at all times during event hours.
- 3) Each participant is responsible for collecting and submitting sales tax to the Florida Department of Revenue.
- 4) Vendors/Organizations are required to handle their own clean-up. Remove all trash with you as there are limited resources at the venue.
- 5) All dogs brought by rescues, shelters, and vendors must be spayed or neutered. No dog left unattended.
- 6) No loud generators.
- 7) No refunds due to inclement weather. There is no rain date.
- 8) No refunds due to participant cancellation.
- 9) Non-profit organizations must submit a 501c3 proof of status with application.
- 10) Spaces are limited and will be accepted on a first come, first serve basis.

Participation, Waiver of Liability, and Assumption of Risk Assessment
